

RENEWALS OUT OF COUNTY

Out of County renewals must provide a copy of their firearms training and application from their initial permit. Applicants are responsible for contacting their former County for information. This information can be mailed or faxed to our office.

For name and address changes, you must go to the Driver's License Office. The fee is \$5.00. Note – This is for Bonner County issued permits only.

NOTE: CWP Licenses issued in other states cannot be renewed in Idaho.

FINGERPRINTS MUST BE TAKEN BY A LAW ENFORCEMENT AGENCY WITHIN BONNER COUNTY – THEY ARE TAKEN AT THE JAIL ON:

Tuesday, Thursday from 9:00 a.m. to 11:30 a.m.; Tuesday and Thursday from 7:00 p.m. to 9:00 p.m.; and Saturday 1PM to 3PM.

There will be a fingerprinting fee of \$15.00, cash only, in the exact amount. The jail cannot make change.

STATES THAT HONOR THE IDAHO CONCEALED WEAPONS LICENSE:

While we do our best to keep this list up to date, states are constantly changing their laws and regulations. If you plan to travel **DO NOT** use this list as your official guide. It is *your* responsibility to call the States you are going to be traveling in and make sure you can carry a weapon in that State.

Alabama, Alaska, Arizona, Arkansas, Colorado, Florida, Georgia, Indiana, Kentucky, Louisiana, Michigan, Missouri, Montana, Nebraska, New Hampshire, North Carolina, North Dakota, New Hampshire, Ohio, Oklahoma, Pennsylvania, South Dakota, Tennessee, Texas, Utah, Vermont, and Wyoming.

CRITERIA FOR CONCEALED WEAPON PERMIT

The following is the criteria for applying for a Concealed Weapon Permit:

- ❖ Not under indictment for a felony
- ❖ Not convicted of a felony
- ❖ Not under indictment or convicted of a violent misdemeanor within the last three years
- ❖ Never have been adjudicated as mentally defective or committed to a mental institution
- ❖ Not a fugitive from justice
- ❖ Not an alien illegally in the United States
- ❖ Never discharged from the armed forces under dishonorable conditions
- ❖ Never renounced United States citizenship
- ❖ Never have received a withheld judgment for a felony or violent misdemeanor
- ❖ The applicant is twenty-one years of age or older

FIRST TIME APPLICANT

Fill out a blue applicant fingerprint card, which is obtained in the jail.

Note: Fingerprints must be completed by a Law Enforcement Agency within Bonner County.

Attach documentation of the completion of any hunter safety course approved by the Department of Fish & Game; or any NRA firearms safety or training course; or documentation of training by a law enforcement or military agency. Bonner County Sheriff's Office will not train or certify applicants for liability reasons. It would be unfair to our taxpayers to incur this liability and our manpower levels preclude expenditure of time for that purpose.

Please note your telephone number on the applicant (no space is provided). A background check fee of \$39.75 must accompany your application. This is non-refundable. The remaining \$22.70 will be collected when your application is approved.

After the application has been processed and your fingerprint card returned from Boise, your permit will be sent to the Driver's License Office. We will mail you a letter and let you know when your permit is ready. The permit is valid for five (5) years.

RENEWALS

The renewal fee is \$37.70. \$20.00 will be paid at the Sheriff's Office; \$17.70 will be paid to Driver's License when you pick up your permit. You may renew up to 90 days before the permit expires. Once the permit has been expired for three months, you will be charged a late fee of \$10.00. If the permit has been expired for over six months, you will be required to repeat the initial process (Idaho Code 18-3302).
